**ENROLMENT ACCEPTANCE FEE - \$100 per new family (deducted from fees)**

A variation of fees in the form of an extension of time for payment or a reduction in the level of fees may be approved for families experiencing demonstrated hardship.

All fee variations are treated confidentially and are addressed on an annual basis.

### PAYMENT TERMS

Invoices will be issued to you early in the new school year. Please note that any payment arrangement entered into is purely administrative. Notwithstanding the amount invoiced, in the event of default on payment arrangements the total amount outstanding will become immediately due. The school reserves its right to take steps to recover payment in full.

### NOTICE OF WITHDRAWAL

Written notice of at least ten weeks is required prior to withdrawal of a student from the school. Where notice is not provided, full tuition fees and all levies will need to be paid for the number of weeks where notice was not provided. This includes withdrawal prior to the start of the school year.

For example, if a student is withdrawn at the start of the school year, a total of 10 weeks of school fees may need to be paid.

This notice period may be reduced or waived in special circumstances.
